

Support Mechanism

In accordance with Title 15: Mississippi Department of Health Part 3: Bureau of Acute Care Systems Subpart 1: Trauma System of Care Mississippi State Department of Health Rules and Regulations, The Department has contracted with Mississippi Trauma Care Systems Foundation, Inc. (MTCSF) for Trauma Care Trust Fund (TCTF) for administrative support and the distribution of TCTF funds to designated trauma centers and EMS agencies.

MTCSF shall comply with all MS Trauma System Rules and Regulations and applicable Mississippi State Department of Health (MSDH) policies (including but not limited to policies for audits, funding, trauma center designation, and performance improvement).

The Trauma Care Trust Fund (TCTF) shall serve as the financial support mechanism for developing the Mississippi Trauma Care System. MTCSF shall distribute trauma care funds to designated trauma centers and EMS providers as provided for by statute and Trauma System Rules and Regulations; however, the MSDH, not MTCSF, is responsible for determining the amount of funds due and owing to each trauma center and EMS provider and providing the funds to MTCSF for such payment as follows:

- MTCSF shall distribute said funds as calculated by the CPA vendor and provided through MSDH with MSDH's approval.
- MTCSF shall maintain and provide access to all records used in the fund distribution process (including but not limited to trauma center applications, EMS operator applications, account ledgers, copies of checks or payment records) for review during the Annual Programmatic and Financial Audit (to be carried out by MSDH in October each year for the previous fiscal year).
- MTCSF shall retain all program and financial records for a minimum of three (3) Years.
- MTCSF may withhold payments from the Trauma Care Trust Fund when notified by the MSDH that a trauma center or EMS agency is not in compliance with Trauma System Rules and Regulations and/or MSDH policy.ⁱⁱ

Scope

As of May 2020, the Trauma Care System comprises 86 trauma centers designated at their respective level based on staff and resources: 4 Level I Trauma Centers, 3 Level II Trauma Centers, 16 Level III Trauma Centers, 62 Level IV Trauma Centers, and two burn centers.

Pertaining to education, MTCSF shall be responsible for specific ongoing educational obligations, including:

- A. MTCSF's annual education obligations shall include coordinating and providing a yearly trauma care symposium.
 - The symposium shall provide opportunities for the ongoing training of surgeons, physicians, nurses, paramedics, and other health practitioners directly involved in trauma care.
 - The symposium shall provide training opportunities for trauma medical directors, trauma program managers, and trauma registrars.
- B. MTCSF quarterly education obligations shall include coordinating and providing ongoing quarterly training for trauma program managers and registrars on a verified cost basis.
- C. MTCSF monthly education obligations shall include coordinating and providing educational opportunities for new trauma program managers and registrars and credential courses for surgeons, physicians, nurses, paramedics, and other health practitioners directly involved in trauma care. Opportunities may include but are not limited to:
 - •Advanced Trauma Life Support (ATLS)
 - •Rural Trauma Team Development Course (RTTDC)
 - •TNCC (Trauma Nursing Core Course)
 - •International Trauma Life Support (ITLS)
 - •Pre-hospital Trauma Life Support (PHTLS)
 - •Other relevant trauma credential courses approved by BACS & MTCSF, including Advanced Trauma Care for Nurses (ATNC).
 - •Stop the Bleed courses for Law Enforcement and First Responders.
- D. MTCSF provides educational reimbursement to Mississippi Trauma Care System organizations as defined by the MSDH/BACS trauma care system.
- E. MTCSF provides educational reimbursements as required by the MSDH Rules and Regulations and details in MTCSF policies.

PURPOSE:

The procedures within this policy will describe how the Mississippi Trauma Care System Foundation (MTCSF) will receive, process, reimburse and report trauma care fund distribution.

POLICY

- A. The MTCSF shall support and/or provide the educational opportunities identified in the Scope of this document. Course opportunities may be offered directly by MTCSF or by MTCSF working with preapproved course directors, instructors, independent contractors, or trauma centers.
- B. MTCSF shall develop and provide a report and submit it to the MSDH Bureau of Acute Care Systems (BACS) to include a quarterly Education Report, which provides information on the educational opportunities offered by MTCSF:
 - 1. Include the name and/or type of course.
 - 2. Total number of persons completing the course,
 - 3. A summary of pre and post-surveys submitted by persons completing the course.
- C. MTCSF staff may offer educational opportunities. MTCSF may sub-contract course managers and/or instructors or reimburse preapproved courses provided by individuals or businesses/agencies approved by the MTCSF. The MTCSF leadership will select subcontractors based on criteria including price, quality of product or services, references, customer service, integrity, professionalism, recommendation, and existing relationships.
- D. When educational offerings are subcontracted to instructors, hospitals, or agencies, reimbursement will be paid based on the approved *Fee Schedule* (item G). This should be a single submission, including all support documentation, as directed by the *Request for Approval and Payment Form*.
- E. If the educator requests itemized payments, as charges are incurred, the following process will be followed:
 - 1. The request will be submitted sixty (60) days before the class date to meet precourse training module timelines and avoid the cost to the course provider(s),
 - 2. Training manuals may be prepaid to the requesting party on a cost basis when submitted with an invoice and request for payment form.
 - 3. MTCSF will pay the balance to the requesting party upon course completion and submission of required support documentation based on the approved *Fee Schedule* (item G).
 - 4. Course Completion invoices and support documentation shall be submitted within thirty (30) days of course completion.

F. Availability of Funds

- 1. It is expressly understood and agreed that the obligation of the MTCSF to proceed under this agreement is conditioned upon the availability of funds from the responsible party and/or the receipt of state and/or federal funds.
- At any time, if the funds anticipated for educational courses are not forthcoming or insufficient, pre-approval and/or reimbursement may be delayed or denied until such funds are provided to the MTCSF by the responsible party and/or the receipt of state and/or federal funds.

G. Emergency Medical Services / Ambulance Services

Reimbursement for EMS education is provided, as approved by the Bureau of Acute Care Systems and directed by the Rules and Regulations provided by the Mississippi Department of Health Part 3: Bureau of Acute Care Systems Subpart 1: Trauma System of Care.

PROCEDURES:

A. Control of documented information shall be assured by using the Mississippi Trauma Care System Foundation (MTCSF) as appropriate, and the request may be submitted by the hospital leaders, physicians, advance practice professionals, trauma program managers, course directors, and/or emergency medical service providers. These documents are found at https://mstraumafoundation.org/resources/.

B. Request for Approval and Payment:

- 1. Complete the *Request for Approval and Payment Form* and return it as an excel file. It is a working document, and scans will not be accepted.
- 2. Submit a completed w-9 with a valid and legible address. This address is where your check will be mailed. This is required for all reimbursements.
- 3. Complete the evaluation forms that can be found on the website.
- 4. Email request for approval to the Mississippi Trauma Care System medwards@mhanet.org; Request payment to medwards@mhanet.org or another designee.
- 5. Email subject line verbiage: Request for Approval and Payment.
- 6. Electronically attach the requested support documentation (as stated on the Request for Approval and Payment Form).

C. Processing Request for Approval and Payment:

- 1. The MTCSF Director, or designee, will review the completed *Request for Approval and Payment Form* and required support documentation for approval.
- 2. *Proceed to Payment* notification will be emailed to MTCSF accounts payable and the requestor to confirm acceptance.
- 3. Payments will be made by check via mail to the requesting person or business. Electronic payment can be made upon request.

D. Non-Resident / Self-Payment Students

 Students who are not employed by Mississippi Trauma Centers or Mississippi EMS services may attend classes; however, they will not be eligible for Mississippi Trauma Care Trusts Fund reimbursement. These students must self-payment.

- 2. Students who are not eligible for MTCTF reimbursement (ex., Out-of-state employers, veterans' hospitals, tribal hospitals, unapproved repeat courses) may self-pay. There are two methods of self-payment:
 - a. Preferred Method: Students may pay the course director or instructor directly, as defined by the course director. These students must not be included in the MTCSF request for payment/reimbursement.
 - b. Alternative Method: MTCSF can directly bill students, subject to a \$25.00 processing fee. The Course Director should contact MTCSF for invoicing instructions.

E. Incomplete Request / Denials

- 1. Incomplete requests will be returned with a request for additional information, which may be resubmitted and reprocessed.
- 2. If the request is denied, an explanation of non-coverage will be provided to the submitter.
- 3. Appeals of denial are accepted for review by the MTCSF director, treasurer, and/or board of directors, as necessary.
- 4. Miscellaneous and other distribution of funds must be preapproved by the MTCSF Director and MTCSF Treasurer and reported to the MTCSF Board of Directors.

F. Repayment of Unused Funds

- The requestor/requesting organization assumes sole responsibility for reimbursement to the MTCSF (funding agency) of a sum of money or material equivalent to the amount of any expenditures disallowed or unused for stated educational purposes. Disallowed expenditures may be identified through internal or external audit processes.
- 2. Education is provided on a cost basis. The Fee Schedule is the maximum expected reimbursement and shall not exceed the Fee Schedule. Extenuating circumstances must be preapproved.
- 3. Instructors/Course Directors are expected to adhere to criteria established by the course certifying organizations to be eligible for reimbursement. Variation from established student/instructor ratios or other course requirements is subject to reimbursement denial.
- 4. When course books are provided to students in advance, the student is responsible for completing the course. If the student does not complete the course, they must return the new book or pay the course book's cost.
